10. a) What was the general character of your practice, dividing it into periods with dates if its character changed over the years?

My solo practiced changed greatly over the years. It began primarily as research and writing for other attorneys. These assignments included post sentencing motions and briefs in support thereof, and appellate briefs to the Pennsylvania Superior and Supreme Courts. As I began to grow a client base, my practice shifted to direct client representation at preliminary hearings and trials in the criminal division. Gradually, cases took me to courts in most of the surrounding counties, but especially Westmoreland and Washington Counties.

I also began to represent clients in more areas of the law: civil cases, landlord and tenant actions, family law cases, juvenile court proceedings, and hearings before Pennsylvania administrative bodies, mostly dealing with

unemployment claims. By the early 2000's, I had reduced my private practice to a few established clients and referrals from them, due to time constraints from a new position I had taken as a Legislative Assistant for State Representative Paul Costa.

As an attorney with the Office of the Public Defender, my practice was concentrated on preliminary hearings and pretrial issues, as well as post trial matters, issues of probation and parole, and commitment proceedings at mental health facilities. When I was in the trial division in 1994, I found that schedule greatly interfered with my ability to maintain a healthy solo practice, so I returned to pretrial services until taking on a full time management position in 2004.

From 2004 to 2010, my the last six years at the Office of the Public Defender's Office, my position in management allowed me the opportunities to represent individual clients in court as well as manage the people under my supervision.

b) Describe your typical clients and mention the areas, if any, in which you concentrated your practice:

My public defender clients were, by definition, indigent people charged with crimes, or facing mental health commitments.

My private practice produced a much more diverse collection of clients. Most were individuals, but I did represent a few small businesses. Most were people of modest means. Many were people who made too much to qualify for an attorney from the Public Defender. Some were people of means, and more than a few were family and friends in moments of need.

As I stated in the previous answer, my practice evolved over the years. It was, however, usually interesting, especially when I got the opportunity to practice in an unfamiliar area of the law, or a different county.

Since July of 2010, I have been the Magisterial Judge for Court 05-2-08, which comprises the communities of Braddock Hills, Chalfant, Churchill, Forest Hills and Swissvale.

I was appointed to the bench by Governor Edward Rendell, following the recommendation of State Senator Jay Costa. The court was vacated by the Honorable Susan Evashavik-Dilucente, who had been elected to the Court of Common Pleas in November of 2009, and took the bench in January of 2010. I was unanimously approved by the Pennsylvania State Senate.

I was elected to a full six-year term in 2011, and to a second in 2017.

As a Magisterial District Judge, the limit of my court's jurisdiction in landlord and tenant, and civil matters is \$12,000.00. I have final jurisdiction in all summary traffic

and non traffic cases. I conduct preliminary arraignments, set bond, and hold preliminary hearings in all criminal matters before me.

As a Magisterial District Judge, I hear a wide variety of cases touching on every area of the law. I hear traffic and non-traffic summary matters, including truancy cases from the Woodland Hills School District. Violations of borough ordinances, especially property maintenance and building code violations are heard at least one day per month. Civil matters, such as debt collection cases and breach of contract issues, with a limit of \$12,000.00 in damages are heard several times per week, as are landlord and tenant cases for both residential and non residential properties. I review and sign when appropriate search and arrest warrants. I arraign defendants and set their bail, and conduct their preliminary hearings.

I was elected as a member of the Churchill Borough Council in November of 2005. I served a four-year term and won a second term in 2009. I had to resign from that position in July of 2010 prior to being sworn in as Magisterial District Judge. I was Council President from January 2008 until my departure.

In 1996, I ran for a seat in the Pennsylvania House of Representatives, 34th District. In 2001, I ran for Magisterial District Judge, coming in second to Judge Evashavik-Dilucente.

24. Have you ever been disciplined or cited for a breach of ethics or unprofessional conduct or has any complaint against you been filed with the Court of Judicial Discipline? If so, give the particulars:

I have never been disciplined for a breach of ethics or unprofessional conduct. Four complaints were filed with the Court of Judicial Discipline.

One case involved a landlord who had filed a complaint against her tenant seeking possession of a rental property in Swissvale. That same unit was the subject of a non-traffic complaint filed by the borough for moving the tenant in without first obtaining an occupancy permit. The landlord failed to respond, and there was a warrant for her arrest. The borough routinely withdraws the citations once the occupancy permit is granted. I asked the landlord if that had been resolved so I could dismiss that case and recall the warrant. She resented the question and filed a complaint. The court requested the files for the cases and a written explanation from me. The case was dismissed without a hearing.

In the second case, a man claiming to be a sovereign citizen was charged with harassing his neighbor. After receiving the complaint, he began to harass the staff at my office. It started as insulting and demeaning phone calls. Then he began to come into the office and yell at them in person. The abuse did not abate, despite our attempts to address his concerns. Most concerning was the fact that the intensity of his behavior increased each day. Staff's fears grew with each encounter, and per AOPC protocols they put the office into lockdown on more than one occasion following his comments to them. His behavior towards me, and the male police officers that dealt with him, was less abusive than what he directed to the four women who work in my office. After five consecutive days, several in-person instances of harassment and dozens of phone calls, the police arrested him for obstruction when he began to interfere with members of the public trying to access the court.

On day four the staff had received over 30 phone calls from this person. The police arrived to try to convince him to leave. It was the second time that day he had to be escorted out. This interaction was captured on an officer's bodycam. Over 20 minutes later, he finally left. Immediately after, the officer came into the staff area without turning off his camera. When he asked what to do next, I said to shoot him. It was said sarcastically in an attempt to break the tension. This video was turned over in the discovery process, and the defendant posted it to YouTube. I alerted court administration and made them aware. Several months later, it was edited and posted to FaceBook. I was not in the office when a reporter arrived seeking comment, since I had taken the afternoon off to prepare for my wedding later that day. A statement of apology was drafted and released. The court reviewed the case filings only. I was never asked for a statement. The case was dismissed without a hearing.

The other two complaints were dismissed without any information sought from my office. I have no idea who filed them, or what they were about. I merely received dismissal letters.

I am a member of the Special Court Judges Association of Allegheny County since 2010. For the last two years, I have been Second Vice President of that organization.

Since 2018, I have been a member of the Special Court Judges Association of Pennsylvania. I sit on the Crimes Code Committee, which reviews pending legislation, makes comment as appropriate, and makes recommendations to legislators.

29. List your experiences in teaching and lecturing, including law school, continuing legal education, both for the legal community and the judiciary, and to non-legal audiences.

I do not have a regular teaching position, but I have been a guest lecturer on many occasions:

I have lectured on the role of the Judiciary to students at the Community College of Allegheny County.

I have lectured on the legal system, the Judiciary, and the role of local government at Point Park University.

I served as a Judge for mock trial students at Carlow University.

I lectured students on practicing before the Minor Judiciary at the University of Pittsburgh School of Law.

I co-presented on changes to the rules of criminal procedure to members of the bar and the Judiciary at the Bench Bar conference.

The ACLU was invited by the President Judge to provide legal education to the Minor Judiciary of Washington County on the issue of cash bail reform. I was one of the peer presenters who instructed the Judges how I have reduced cash bail in my court.

Following the U.S. Supreme Court decision in *Obergefell v. Hodges*, the marriage laws in Pennsylvania were changed to allow same sex couples the same right to marry as heterosexual couples. I was proud to perform one such wedding the first day they were permitted. While some judges changed their policy about weddings to avoid the issue, I feel that I have a responsibility to make the court a place where all are welcome.

I serve on the board of trustees for the Fair Housing Partnership, based in Pittsburgh. This organization works to ensure that all federal and state laws and regulations relating to fair housing are followed. I believe that housing discrimination is an area that needs to be addressed. My work in this area makes me sensitive to the ongoing challenges many in our community face

33. Why do you wish to become a Justice or Judge? What special strengths do you feel you possess that would particularly well qualify you for the position of Justice or Judge?

I have unique qualifications that set me apart from the other candidates. I have the most judicial experience by far. For over a decade, I have been a Magisterial District Judge, deciding thousands of cases that touch on every area of the law that a Common Pleas Court Judge deals with. I have presided over cases from traffic violations to criminal homicide. No case is bigger than the case in front of me at that moment. The litigants before me, whether involved in a serious criminal case, a civil suit, a landlord-tenant issue, or a summary traffic case, are dealing with a major life event, and I treat them as such.

During my time on the bench I have developed a judicial philosophy that serves me well. I give each side the respect and time they deserve, and I encourage the parties to resolve their issues and arrive at a solution. This gives both sides ownership of the outcome as something they took part in, rather than a decision imposed from outside.

However, I understand my role. None of the cases brought before me are about me. The cases are about the parties, and when I am involved, it is because the parties could not arrive at a resolution. When that happens, I listen carefully to each case and make the best decision I can under the law. Not everyone leaves happy with the outcome, but everyone leaves knowing that he or she has been heard by the court.

My law practice prior to taking the bench also adds to my qualifications. As an attorney for the Allegheny County Office of the Public Defender, I saw first hand how the criminal justice system treats poor people - especially African Americans. For nineteen years, I fought for the rights of the accused. Criminal justice reform is not something that I had to study. I understand the problems and I am part of the solution and will continue to be.

I am incredibly proud of the work done at the Office of the Public Defender. During my time there as a member of the management team, the office progressed and was able to be released

from the consent decree put in place to increase staffing, funding and other issues critical to fair representation. When I was hired as an Assistant Public Defender, all attorneys were part time and were paid a relatively low salary. As a result, most attorneys maintained a separate private law practice. Until 2004, my practice afforded me the opportunity to practice in many of the surrounding counties. Learning the procedures in other jurisdictions broadened my skills. In fact, I did my best to learn from every Judge before whom I appeared. Sometimes the lesson was what not to do. Regardless, I always learned something that I can still use today in my courtroom.
