#### 10. With respect to your practice:

- a) What has been the general character of your practice, dividing it into periods with dates if its character has changed over the years?
- (I) From 3/1994 to 9/1994, I was an Attorney Decision Writer assigned to Workers' Compensation Judge Rosalia Parker. During that time, I reviewed the closed records of cases, attorney's legal arguments, and the relevant legal precedents, then based upon my independent analysis, I drafted Findings of Fact, Conclusions of Law, and Orders for Judge Parker to review, revise, sign and file.

- (II) From 9/1994 to 5/1997, I worked for Ogg Jones Cordes & Ignelzi, LLP which concentrated in plaintiff's workers' compensation, plaintiff's personal injury litigation, and plaintiff's employment claims. During that time, I was primarily focused on workers' compensation litigation involving administrative proceedings and some appellate work representing injured workers against their employers. I also handled compulsory court arbitration hearings involving various disputes, including car accidents. I was also lead counsel on a vaccine injury case before the Federal Court of Claims, the injured party was a minor who was profoundly disabled following seizures that were medical connected to DPT vaccine. After a 12-hour hearing before an Administrative Law Judge, I established liability against the Vaccine Injury Fund.
- (III)Upon beginning my new employment with Malone Larchuk & Middleman, PC, I was assigned various insurance defense matters. These matters included (1) defending employers and insurance carriers from work injury claims; (2) defending insured companies, including municipal corporations and agencies, from liability claims based upon negligence; (3) defending a self-insured cab company from various claims made against their drivers; and (4) a few plaintiff's personal injury lawsuits filed for the plaintiffs. During this time in my career, I regularly filed pleadings, conducted discovery, and motions practice, and attended administrative law proceedings, arbitrations hearings, jury and nonjury trials. Over my 13 years with this law firm, I handled hundreds of court cases and I estimate that I tried about 10 jury cases to verdict in various Pennsylvania counties, with the rest settling. I also handled a 5-day commercial arbitration case involving a "bet the company" franchise dispute under AAA commercial arbitration rules. Towards the end of my tenure with the Malone law firm, I handled a complex plaintiff's medical malpractice case as lead counsel, which tried for 5 days and eventually settled favorably after closing arguments. I also handled a federal intellectual property, trademark and misappropriation of trade secrets trial which settled favorably for my defendant client after pre-trial motions.
- (IV) In November of 2009, I accepted an offer at Ference & Associates LLC. There, my practice transformed from litigation in State and Federal courts to more administrative proceedings. Indeed, during the Fall, I handled two Automobile Dealership Termination cases under the Federal Law enacted to permit Chrysler and GM dealerships seeking reinstatement of their franchises following rejection under the Bankruptcy proceedings for each manufacturer. Thereafter, my practice has focused on Intellectual Property, including Copyrights, Trademarks, and Patents. I have managed international trademark portfolios, filed and prosecuted about 100 trademark applications before the United States Patent and Trademark Office, as well as filed and defended Oppositions and Cancellation proceedings before the Trademark Trial and Appeal Board. I have also handled various Trademark Infringement lawsuits in the Western District of Pennsylvania, with each (with the exception of one) ending with a final default

judgment. I also have handled the occasional unemployment, social security disability, business litigation, and workers' compensation case since joining Ference.

- (V) In May of 2018, my practice began to focus on online anti-counterfeiting work for clients. This involves obtaining evidence, filing cases under seal, presenting applications for ex parte temporary restraining orders, then preliminary injunctions, then final judgments for equitable relief and damages. To date, I have been second seat for 17 federal lawsuits, with one in the Southern District of New York and 16 in the Western District of Pennsylvania. 12 have resulted in default judgments against counterfeiters with a combined total of over 350 Million Dollars. Five cases remain pending final judgment.

I continue to appear in court occasionally. Typically, I will present in the Court of Common Please before one of the motions judges. Arguments have varied from discovery to preliminary objections. I have handled a few Arbitration Hearings in Allegheny County and have sat on the Board for Landlord Tenant Matters and General Matters. I have been a volunteer attorney for the Allegheny County Court of Common Pleas Housing Court. I have also handled a few traffic court appearances before local magistrates. Most recently, I have handled cases before the Court of Common Pleas brought by the Pittsburgh Human Relations Commission against my client for alleged housing discrimination.

- 13. Describe five of the most significant litigated matters which you personally handled and give the citations thereto, if the cases were reported.   - I. In Montanari v Vaccine Injury Fund, an unpublished vaccine injury claim, I represented the injured minor and her parents before the Federal Claims Court. The claim was that after receiving a DPT injection, the minor suffered severe afebrile seizures causing permanent and profound brain injury. I was lead counsel on the case during 1996 to 1997. The case was assigned and tried before Special Master French, a Federal Administrative Law Judge who traveled from Washington D.C. and conducted in the Western District of Pennsylvania. After conducting a 12-hour trial on liability, including considering expert medical testimony for my clients and the fund, the Special Master found liability against the fund. I do not recall the name of opposing counsel for the government.
  - II. In Zavodchikov v Applegate, GD-01-011528, Allegheny County Court of Common Pleas, I represented plaintiffs from 6/8/2001 to 12/17/2002 in their claim for failure to diagnose ectopic pregnancy. The case was particularly sad because plaintiff-wife had only one fallopian tube and the ectopic pregnancy burst that tube making her sterile. With an assist from my law partner, Steven B. Larchuk, Esquire, I handled all aspects of the case from discovery, expert depositions, pre-trial and trial. After a 6-day trial before Judge Ronald Folino, the case settled for the Plaintiff. The opposing counsel was Anne Wilson, Esquire of Dickie, McCamey & Chilcote Two PPG Place Suite 400 Pittsburgh PA 15222-5402, (412)281-7272.
  - III. In *Promote It, Inc. v 4Imprint, Inc.*, litigated in 2002-2003, I represented Mr. McCarty, a franchisee who believed that the company that acquired the franchisor breached multiple portions of the Uniform Franchise Offering Circular and Franchise Agreement. The main theory was that the acquiring franchisor illegally copied Mr. McCarty's database of direct sell customers for promotional items and then directly mailed those customers in order to get

their business. I drafted and filed the complaint, performed all the discovery and motions practice and tried the case before a specially appointed Arbitrator under the Franchise Agreement. The franchisor vigorously defended and during a 5-day arbitration in Chicago Sears Tower presented its own computer technician to establish its defense. I crossed the technician discussing the technical aspect of data base management and manipulation and established that it was possible to read my client's database and copy it into the defendant's database. The arbitrator awarded my client breach of contract damages and attorney's fees and costs. The opposing counsel was Catherine M. Burkhardt, Esquire, Piper Rudnick, 203 North LaSalle Street, Ste 1800, Chicago, IL 60601-1293, (312)368-4086.

- IV. In Krebs Chrysler Jeep, Inc. v. Chrysler Group LLC, Case No. 55 532 00019 10, from 11/2009 through April 2010, I represented a terminated Chrysler dealership that was seeking reinstatement under the federal law enacted that permitted dealerships that were terminated under the Chrysler or General Motors Bankruptcy proceedings to seek reinstatement before an agreed upon Arbitrator. I filed the claim, handled all the discovery, motions practice, pretrial and trial with an assist from my wife, also a lawyer, as second seat. After a 5-day trial before retired Judge DelSole, we received a decision that that dealership would not be reinstated despite meeting all the criteria because once terminated the dealer still owned a second Chrysler dealership. The opposing counsel was Dyane L. O'Leary, Wilmer Hale 60 State Street, Boston, MA 02109, (617)526-6442.
- V. In *Mitsubishi Electric Power Products v Integ et al.*, GD No. 15-18659, I was sole counsel and defended Integ from multiple counts for Breach of Contract. After motions practice spanning many years, including judgment on the pleadings and discovery, the case was resolved amicably. The opposing counsel was Robert E. Dauer, of Meyer Unkovic and Scott, 1300 Oliver Bldg, Pittsburgh, PA 15222, (412) 456-2800.

From November of 2015 to May of 2018, I practiced about 75% before the United States Patent and Trademark Office Trademark Trial and Appeal Board, handling trademark opposition and cancellation proceedings. I have also prosecuted patents and trademarks before the United States Patent and Trademark Office about 25%.

Though I continue up to the present prosecuting applications for copyrights, patent, and trademarks, since May of 2018, I have concurrently prepared and filed 17 federal

lawsuits (1 in the Southern District of New York and 16 in the Western District of Pennsylvania, which required investigation and prosecution of claims for on-line counterfeiting, both international and domestic. During the investigation, it was learned that the counterfeiters were manufacturing, offering for sale and selling cheap knockoffs of the client's authentic products. Under Trademark and Patent law, in each instance, we filed sealed complaints and applications for temporary restraining orders and preliminary injunctions. We obtained the orders *ex parte*, then served the defendants using alternative electronic means on a litigation web site. We sought and obtained restraining orders from the third-party service providers that were providing the web sites and financial services to the counterfeiters and had their assets frozen during the pendency of the litigation. Combined, 12 concluded cases resulted in 100s of takedowns of counterfeit products and default judgments in excess of 350 Million Dollars. Five cases remain pending final judgment.

About 22 years ago, I was served with a civil complaint for alleged legal malpractice while working as an associate at Ogg Jones Cordes & Ignelizi, LLP. The case is *Duncan et ux. v. Malkin and Ogg Jones Cordes & Ignelzi LLP et al.*, GD No. 98-003608. There was an allegation that a limitations period was missed for filing a reinstatement or claim petition for a workers' compensation case. The evidence revealed that there was no medical evidence to support a disability arising from the alleged work injury. After the plaintiff deposed the partner in charge of the case, Jonathan E. Jones, Esquire, the case stalled, the plaintiff's lawyer withdrew their appearance and the case remains pending on the docket up to today.
